From the Cleveland (Ohio) Civil War Roundtable, we are pleased to welcome **Brian Kowell** to our virtual meeting for a 20-30 minute talk on "John Barleycorn -- Alcohol in Blue and Gray."



Brian Kowell was born and raised in Cuyahoga County, Ohio. Graduated from Baldwin-Wallace University in 1973 with a B.S. in Biology. Worked for 38 years as a salesman/trainer in the pharmaceutical industry. A member of the United States Professional Tennis Association, I have been teaching tennis for 55 years in Ohio, Hawaii, Illinois, Texas, Florida and Canada. I have played in the USTA National Senior tennis tournament held in Florida and Arizona 2017-2021. Currently teach tennis at Towpath Tennis Club, Akron, Ohio.

Became interested in the American Civil War in 5<sup>th</sup> grade and have been studying the war ever since. Joined the Cleveland Civil War Round Table in 1975, holding all the executive positions including president and newsletter editor. Have organized and led numerous civil war fieldtrips. Was a charter member of the Northeast Ohio Civil War Round Table. Have published articles in *America's Civil War* magazine and the Emerging Civil War website as well as contributing articles in the "Charger" – the newsletter of the Cleveland Civil War Round Table. #### February 1862

#### The Western Theater

As the Civil War entered its second year several battles occurred in both the eastern and western theaters of the war. It also saw the emergence of Ulysses S. Grant as a general to be reckoned with. It was this month that he earned the nomme de guerre of Unconditional Surrender Grant. His first battle was the siege and victory at Ft. Henry, Tennessee on February 6<sup>th</sup>. The fort guarded the Tennessee River.

General Grant's two divisions of infantry was supported by Admiral Foote's Western Gunboat Flotilla. Under the bombardment of the gunboats the CSA commander as for terms of surrender. It was Admiral Foote who sent back the reply, "No Sir, your surrender will be unconditional!" The surrender opened the Tennessee River up to Union forces and invasion routes into northern Alabama and eastern Tennessee to Knoxville for the rest of the war. Union casualties were 40. Rebel casualties were 169 including more than 90 captured.

Less than a week later General Grant's two divisions marched a short distance, only 12 miles, to the Confederate Fort Donelson where the Cumberland River flows into the Ohio River. The Cumberland River opened an invasion route for the federal army all the way to Nashville. Admiral Foote's gunboats sustained severe damage from the cannons of the fort and were forced to withdraw. Grant's army surrounded the fort. The CSA commander escaped leaving Brigadier General Simon B. Buckner in command. He surrendered "unconditionally" to General Grant late that afternoon. The battle resulted in virtually all of Kentucky as well as much of Tennessee, including Nashville, falling under Union control. Union casualties were 2,691. Rebel casualties were 13,846 including 12,400 captured.

At the end of the month the Union Army of the Mississippi under General John Pope began the Siege of Island No. 10 and were supported by Admiral Foote's flotilla. The siege lasted five weeks and the island surrendered on April 8<sup>th</sup>. It was the first loss of a Confederate position on "the Gathering of Waters" during the war. The Mississippi River was opened up to a short distance above Memphis. With New Orleans surrender in April, the Confederacy was in danger of being cut in two. Union casualties were 78. Rebel casualties were 30 killed or wounded and including 7,000 captured.

#### **The Eastern Theater**

The Battle of Roanoke Island in North Carolina was fought on February 7-8 of 1862. The Union Army there was commanded by General Ambrose Burnside and supported by the North Atlantic Blockading Squadron commanded by Admiral Louis "Old Guts" Goldsborough. Union casualties were 264. Rebel casualties were 2,643 including 2,500 captured.

Such losses for the South were unsustainable.

Admirals Foote and Goldsborough and Generals Grant, and Pope are worthy of further study.

Camp Name: There were several GAR Posts in the area so we decided to keep that tradition alive and name ourselves after the GAR post here. We will be the Major General Edward O.C. Ord Camp #3 after that GAR Post. Gen. Ord was a storied general officer and postbellum was assigned Commander of the Department of Texas for his last posting. He supervised the construction of Fort Sam Houston so it should not be a surprise a GAR Post was named for him.

## My Civil War Ancestor -- Julius A. Stevens By Todd Wilber

My fourth great uncle Julius A. Stevens was born on January 28<sup>th</sup>, 1823 in Wilmington, VT. By 1850, he is married and living in Heath, MA. By 1855, he has moved his family to Shawano, WI. He is residing in the town of Omro, WI at the outbreak of the War of the Rebellion.

On September 8<sup>th</sup>, 1861 Julius enlists in Company C, 14<sup>th</sup> Wisconsin Infantry. He is mustered in on January 30<sup>th</sup>, 1862. He is appointed 5<sup>th</sup> Sgt on November 15, 1861. By May 1862, he is 1<sup>st</sup> Sgt. Julius was in the hospital from May through July and is discharged by order of General Grant on August 31<sup>st</sup>, 1862.

The 14<sup>th</sup> WI Inf took part in second day of Shiloh and the Siege of Corinth during Julius' service. Julius was not done. On September 13<sup>th</sup>, 1864 he enlisted in Company E, 1<sup>st</sup> Wisconsin Cavalry. He was mustered in on September 21<sup>st</sup> for one year's service. He is shown present for duty until May 1865 when is in the hospital in Nashville. Julius had his right leg amputated to the upper third due to gangrene from an injury contracted in the service. He is given a disability rating of 2/3s and is discharged on September 8<sup>th</sup>, 1865.

The 1<sup>st</sup> WI Cav took part in Wilson's Raid during Julius' service. Julius becomes a founding member of GAR J.F. Sawyer Post 7 in Omro, WI in 1880. Julius passes away from stomach cancer on March 23<sup>rd</sup>, 1882 age 59. He is buried in Omro Cemetery.
