The purpose of this Annual Report is to provide an overview of the past twelve months of activity. In terms of numbers, the 2004-2005 year ended up on the plus side, with over a 5% growth in membership. While losses and gains have been experienced in the various Units, five new Units have been added to the 2005 SVR Roster contributing a total of 47 men and only one Unit was disbanded, with 10 of the 13 men of that disbanded Unit immediately proceeding to form a new Unit. To continue on the positive side and with three Units up and running, the Seventh Military District was reactivated on 21 July 2005 and on the aforesaid date a new District Commander was appointed. The reactivation of the Seventh Military District was memorialized in Special Order 2005-02 and in conformity with the provisions of Article III, Section 4 of the Regulations of the Sons of Veterans Reserve.

Battery A 3rd US Artillery, SVR at Ft. Point

On August 13, 2005 the American Civil War Association, a primarily Northern California reenacting group, organized a living history day at the Presidio of San Francisco's Ft. Point. Ft. Point is the only brick Civil War fort west of the Mississippi. The most asked question is, "Did the fort ever fire its guns at an enemy?" This is up for debate. The commander of Ft. Point, an appointment made by President Lincoln before the war because the existing commander was pro-southern, could have been mildly paranoid. I say that not only because he was secretly sent to seize the fort from its pro-southern commander, but the engineer of fortifications on Alcatraz had been accused of espionage for allowing photographing of the artillery batteries there (that union officer's father was an officer of the Confederacy). Confederate raiders were sailing the world's seas looking for plunder to support their war effort and San Francisco Bay was the entrance to gold banks in San Francisco and Petaluma which could have been plundered. During the Civil War the Union suspected the English of entering the war on the side of the Confederacy. It was in this distrustful climate that British Royal Navy vessels entered the Golden Gate without dipping their colors, the customary salute at the time. The Fort's guns went into action, which promptly brought about both the appropriate salute and outrage from the English officer.

Another instance of the fort's guns firing upon a ship was the celebration of our country's centennial. A ship, laden with kegs of black powder, was anchored in San Francisco Bay. Great crowds gathered all around the bay, as they do every year to watch the fourth of July fireworks. Instead of a fireworks show, at the appointed time all the batteries at Ft. Point, Angel Island, Alcatraz and Marin fired upon the ship in an attempt to create a huge explosion. To the horror of the numerous civil war veterans in the audience, the sitting duck target ship survived for over an hour without being hit. Finally, an officer rowed a boat out to it and lit a fuse. The last time we know of the fort's guns being fired was in a Presidential Salute near the turn of the 20th century.

On the cold windy August Saturday in 2005, the commander, Lt. Welch led members of the SVR Battery in participating in the garrison size flag raising and lowering ceremonies. The large size of the flag and the flagstaff's location attached to the corner of the fort requires many troops on the parade ground and troops posted on the tiers and top deck to prevent the flag from becoming entangled while being raised or lowered. Battery members participated in the unfolding and folding.

Throughout the day, Battery members manned an information table and answered questions for the public while ACWA members ran artillery and Zuoave bayonet drills.

Ft. Point is open Friday, Saturday and Sunday during the summer and weekends in the winter. Battery A's next event there will be in January, just as cold and windy as August, so bring your greatcoat. There is a good sampling of artillery, both heavy and light, projectiles, full powder magazine (empty kegs, of course), and soldiers living quarters. See you in January! 2nd Lt. A Eulogy to Brother Al Hodges as Delivered by Captain Bob Lowe, Adjutant 6th Military District, at Al's Memorial Service

Elks Lodge #1812 on August 27th, 2005

Al Hodges was a quiet, perhaps overly modest man, acutely conscious of his responsibilities and prone to deprecate his own charms and abilities. He was a splendid man of great knowledge and big heart. This loved and loving husband and father was also my best friend and colleague over the past 21 years, when work and leisure brought us into almost daily association.

Al worked tirelessly on the "Camp Beyond the Scars" Committee for 5 years, serving as Chairman 3 consecutive years. Under his leadership, El Cajon Elks Lodge 1812 was able to send dozens of burn victim children to a special camp that enabled them to learn how to deal with their physical and emotional scars.

Despite his proclivity to understate his contributions and never seeking acknowledgment, Al was named this Lodge's "Citizen of the Year" in 2001, an award in which he was silently, but vastly proud.

Jerry Sayre, Camp 21 Commander of the SUVCW, named Al, "Brother of the Year," last December. This year, he was serving as Civil War Monuments and Memorials Officer. Needless to say, all of our Camp's engineering needs were directed to Al.

Here was a man of superlatively high standards, complete integrity and boundless enthusiasm for whatever task he took in hand. No one, whose privilege it was to know him, is likely to forget the candor of his speech, the courage of his faith or the warm and glowing brightness of his friendship. He never dodged a responsibility, never refused to take on a hard job if it needed to be done. What he preached, he practiced. What he believed, he believed with heart and soul. He fought hard for every cause in which he enlisted, and causes for which he fought were good and right. His devotion to Veterans, Americanism and Patriotism is unmatched.

With a great passion for woodworking, at one time Al made a replica of a Civil War cannon, which measured about one foot in length. He showed it to me and I was most impressed with the detailed workmanship and wished I had one like it. With out a word, he secretly went to work on another cannon, this one for me. It was presented to me at Christmas, last year, with many of our friends looking on. The only difference between his first cannon and mine was that this one was an exact ¾ scale model measuring seven feet in length and about three feet in height. He had also made one further addition to this replica. During the Civil War, there was a famous cannon named, "Big Bill." Al decided to add a hanging plaque with the raised words, "Big Bob," on it. To really get to me, he made the plaque reversible and, when turned around, proclaimed the name, "Big Boob." Such was Al's sense of humor. The "Big Boob" cannon now sits in a place of prominence on our patio, with guests to our house admiring it, but wondering what on earth it is doing there. I'm sure Al is looking down on me, laughing about his gift that keeps giving.

On almost any holiday or special occasion, the Hodges house and yard was a veritable wonder of lights and wooden figures, made by Al. After a year or two, he would tire of the handmade decorations, make new ones and freely give the older ones to anyone who was interested. Such was his generosity.

These are but two of the hundreds of true and humorous stories I could relate about my friend, Al Hodges. I could go on all day.

In closing, I should like to paraphrase the words of the great Abraham Lincoln, who, in his memorable Gettysburg Address said, "The world will little note, nor long remember what we say here, but it can never forget what they did here." In this instance, AI Hodges, an honored, respected and revered member of our organizations, gave of himself unstintingly to the preservation of human rights and liberties and was ever zealous to take and carry through to its ultimate conclusion the cause of those who needed sound, experienced and wise counsel or assistance. AI Hodges was loved by many, his contributions boundless and he leaves a huge void in our lives. Those who knew

Dedication for Daniel S. Burson

September 26, 2005

Co. G 1st Cal. Vol. Infantry has been very busy this month of Sept. On September 17th we dedicated a new headstone for the grave of Daniel Smith Burson founder of the Mother Lode town of Burson, Cal. Daniel was a member of Co D 7th Kansas Calvary. He volunteered for service in 1861. He fought in several battles and was wounded, for which he was honorably discharged in November of 1862. He was a founding member of the GAR post in Burson in 1890. The veterans from throughout the area would gather in Burson every Memorial Day.

Daniel died in 1907 at the age of 77. Co. G served as honor guard for the ceremony. On September 24th we were once again called on for a stone dedication for a fallen hero in Denair, California. A new military headstone was dedicated for Joel Riley Haworth, Corp. Co F 16th Iowa Inf. Corp. Haworth was born in Indiana in 1838. He died November 28, 1917 at the age of 81. Corp Haworth was a veteran of the battles of Shiloh, Luka, Corinth, Miss., and Atlanta, Georgia. He was captured in 1864 at the battle of Atlanta and sent to Andersonville prison. While in prison he suffered a stroke which made him disabled for the rest of his life. Before entering the service, Corporal Haworth was a strong healthy young man. His life was changed forever as a result of seven months of the inhumane treatment he endured at Andersonville. Corporal Joel Riley Haworth's unmarked grave was discovered in Denair Cemetery. Eighty-eight years after his death and one hundred forty years after his great sacrifice for the Union he finally got his just recognition from the SVR-SUVCW. Co. G 1st Cal. Vol. Infantry was honored to host the Ceremony. Those attending were, Lt Charles Gardali,

Civil War soldier finally gets headstone

Although the Civil War took places thousands of miles from the Turlock area, a few of its soldiers made their way here before their lives were over.

One of those soldiers - Joel Riley Haworth - has been buried in an unmarked grave Denair's cemetery for 88 years until the Sons of Union Veterans of the Civil War discovered him two years ago.

The group will hold a dedication ceremony - including an unveiling of a newly-placed military headstone - at 11 a.m. Saturday at the cemetery on the corner of Zeering and Quincey roads on the outskirts of Denair.

George Hussey, part of the Sons group, first heard of Haworth in an old newspaper article where a women's group honored several soldiers buried in the Denair cemetery. Haworth was one of them, but his grave couldn't be found.

After looking through cemetery records and ordering Haworth's service records, Hussey and his group members were able to locate Haworth's grave and give him the proper headstone.

The public is welcome at Saturday's ceremony, which will include the Sons of Union Veterans of the Civil War and Denair's Webelos scouting group. The Webelos will lead the Pledge of Allegiance at the ceremony, unveil the headstone and lay flowers at Haworth's plot.
